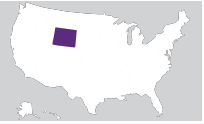


# WYOMING



Wyoming is part of the National Citizen Uprising to pass the 28th Amendment that says: We the People - not money - govern The United States. Wyoming citizens have the power of direct democracy through a Ballot Initiative in the 2018 election cycle. If you want: 1) rights for human beings over privileges for global corporations and special interests; 2) fair and free elections for ALL Americans; 3) rights of all Americans to equal participation and representation, here's what you need to know to help Wyoming make history:

## AT A GLANCE



**SIGNATURES REQUIRED:** 38,818 valid signatures must be collected, filed and verified by February of 2018.



**DISTRIBUTION:** Must meet signature requirement in 16 of 23 counties.



**NOTARY PUBLIC REQUIREMENT:** No, there is no notary requirement.



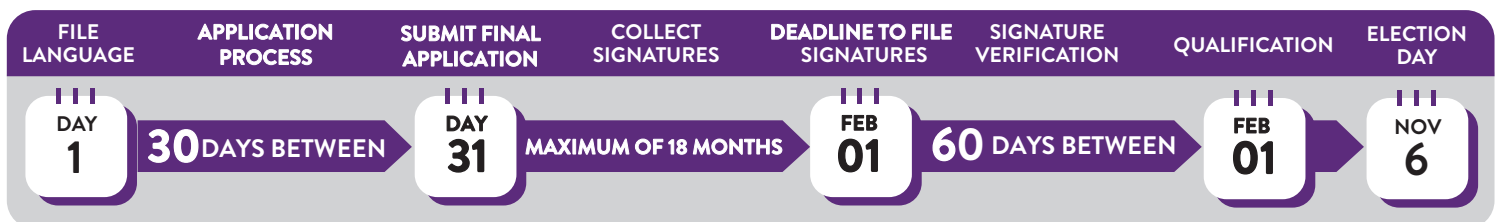
**COMMITTEE REQUIREMENTS:** The application to petition requires the name of three registered Wyoming voters who will represent the sponsors of the initiative.



**SUBMISSION PROCESS:** Signatures must be submitted to the Secretary of State no later than 18 months following the receipt of the petition form.



**WINNING AT THE BALLOT:** Once qualified to the ballot, approval requires a majority of voters who cast a ballot in the election - not just those casting a vote on the measure.



## STEPS TO START THE PROCESS

- ❑ An application must be submitted to the Secretary of State along with a \$500 fee.
- ❑ The application needs to include the proposed bill to be initiated, the designation of a committee of three (3) applicants who shall represent all sponsors and subscribers in matters relating to the initiative, and a statement that the committee of applicants are qualified registered voters who signed the application with the proposed bill attached.
- ❑ Once a review of the proposed initiative has been made by the Secretary's office, a conference will be held with the initiative sponsors to explain any suggested revisions.

## STEPS TO START THE PROCESS (CONT'D)

Within 30 days of submitting the proposed bill, the sponsors must submit a final version to the secretary of state, along with the secretary's comments and the signatures of 100 additional registered voters.

Upon acceptance of the application, the secretary will draft an impartial summary and financial impact estimate to be included on the petition form along with the text of the proposed law.

Copies of the petition are prepared by the Secretary's office at the expense of the sponsor.

## HOW MANY SIGNATURES DO WE NEED TO COLLECT?

The signature requirement is based on 15% of the total votes cast in the previous general election.

258,788 ballots were cast in the 2016 election, making the current requirement 38,818.

The collection of roughly 52,404 gross signatures should satisfy the net valid requirement.

The petition must be signed by a total of 15% of registered voters in 16 of the 23 counties in the state.

## WHO CAN COLLECT SIGNATURES?

Circulators do not need to be residents of Wyoming.

Circulators are required to sign the mandatory affidavit on each petition.

Petitions can only be circulated by one of the original 100 sponsors or an individual designated and registered by the petition committee.

To designate an additional circulator, written notice must be signed and submitted to the Secretary of State by one member of the committee of applicants, verifying, under oath, the names, qualifications, and addresses of those so designated.

## PETITION FORM REQUIREMENTS

The petition is distributed by the Secretary of State. Please contact American Promise for help with forms.

## SUBMISSION REQUIREMENTS

Only the political committee may submit signatures.

Signatures may be submitted only once to the Secretary of State's office in Cheyenne.

All signatures must be submitted by February 1, 2018.

Elections officials have 60 days to verify the signatures.
